

Terms and Conditions for the Stanbic IBTC #Reward4Saving promo.

 - (ii) Reactivate a dormant or inactive Stanbic IBTC savings account and fund said account with a minimum of ₦10000.00 or
 - (iii) Fund an existing Stanbic IBTC savings account or @ease wallet with a minimum of ₦10,000.00
- b. Leave the funds in their Stanbic IBTC account for a minimum of 30 days to qualify for a raffle ticket in the monthly draws
